- I. Structure
 - A. TCNJ Alumni Chapter formed Dec. 2003, approved by Board of Trustees March 2004. The last meeting was held about 3 years ago with 25 people in attendance.
 - B. Constitution & By-laws attached, with proposed changes highlighted in bold. Changes approved unanimously:
 - 1. Immediate Past President may remain as advisor
 - 2. Any registered member can hold office
 - 3. If any officer leaves mid-term, board can appoint acting officer for remainder of term
 - 4. 3 general chapter meetings a year (fall, winter, summer); additional meetings to be posted 14 days in advance
 - 5. 3 members must be present in person, or by phone, for a vote
 - 6. Changes to By-Laws must be approved by Board
 - 7. There will be 3 committees Board can create more as needed:
 - By-Laws & Policies lead by Secretary
 - Fundraising lead by Treasurer
 - Programs led by Vice President
 - C. Chapter goals unchanged
 - D. The Chapter comes under the TCNJ Alumni Association. There are currently 8 Chapters; all get \$1000 operating budget from Association; each has a Chapter representative, appointed by Chapter President, who attends 4 annual Association meetings.
- II. Issues
 - A. Deficiency in alumni/undergraduate interaction. Proposed:
 - 1. Sponsoring alumni or faculty talks
 - 2. Posting company job openings with Career Center
 - 3. Making better use of LinkedIn
 - Look at demographics of current members
 - TASK: Patty will invite all registered alumni with e-mails to join group
 - 4. Work with Alumni Affairs to clean up membership database
